





### GAIN ACADEMIC EXCELLENCE WITH A TECH FOCUS ON 3 CONTINENTS

The MiM - Global Economic Transformation & Technology is a recent and pioneering track in the business education landscape. Its innovation and technology focus will take you on an academic journey from Paris to the SKK Graduate School of Business in Seoul, Korea and the Berkeley Haas School of Business at the University of California, Berkeley (details p. 6).



### APPRENTICESHIP PROGRAM

#### WORK WHILE YOU STUDY

As part of the MiM - Business Management, you can choose our Apprenticeship program. The 24-month part-time program is run from our Paris campus, after an initial four-month period in Lille. The program alternates between one week of classroom attendance and three weeks of on-site work experience, offering a unique opportunity to combine theory and practice and to develop highly marketable skills. You will earn a monthly salary and the remainder of your tuition fees will be paid by your company. A good knowledge of French is highly recommended for positions in France.



### GAIN INTERNATIONAL WORK EXPERIENCE

EDHEC's MiM offers you an outstanding opportunity to gain your first work experience and bolster your international profile with two six-month internships.

For a summer, semester or year, EDHEC MiM students have the opportunity to study at one of our partner universities. You can avail of one of EDHEC's double-degree agreements with a leading international university in place of your second year at EDHEC, you can complete a short-term or full-year exchange in your final year or embark on a semester-long exchange between the first and second years of your master's program. 



### YOUR CAREER TRAINING







## INTERNATIONAL ADMISSIONS — A team to guide you

You will have a dedicated admissions manager to walk you through every step of your application. Do not hesitate to contact them for personalised guidance and advice on the best program for you.

### Requirements

- Minimum three-year bachelor's degree
- Strong GMAT, GRE, TAGE MAGE or CFA Level II (for Finance students only) or CAT official test score report (for Indian students only).
- An acceptable English proficiency test\*: TOEFL internet-based  $\geq 92$ ; TOEIC  $\geq 850$ ; IELTS  $\geq 6.5$ ; Cambridge Test of English  $\geq 175$

- Curriculum vitae
- Letter of motivation
- Academic transcripts
- Two letters of recommendation
- Online interview

\* English native speakers or those holding a degree taught in English (minimum three years) are eligible for an English test waiver.



#### EU nationals

European Union students can live and study in France as long as they have a national ID card. No passport or visa are required.

#### Non-EU nationals

Before arriving in France, students from outside the European Union must obtain a student visa from the French embassy or consulate in their country of origin or permanent residence. Non-EU students must also have a valid passport from their country of origin.

### > SETTLING IN

#### — Meeting your new-found friends

We provide a free pick-up service for students from outside the European Union from the train station or airport in Nice or Lille to the location of their chosen accommodation. Every year, the International Students Office organises orientation events and integration seminars to welcome international students to the EDHEC campus.

### > FRENCH CLASSES

#### — Parlez-vous français ?

French language courses are offered free of charge to facilitate the assimilation of international students.
